What is the TED-Ed Clubs program? The TED-Ed Clubs program was developed by TED Conferences, LLC (“TED”) to support students and teachers who wish to meet regularly to discuss, debate and explore ideas. TED-Ed Clubs provide a forum for students to develop, present and record their own original ideas in the form of short, TED Talk-like presentations. What do I have to agree to? We ask that you provide permission and a release form so that TED can showcase the great work that is done by the students; this allows TED-Ed Club Leaders to record and upload the materials created by Club Members to our site and or to our designated YouTube channel to share with other TED communities worldwide. Due to the Children’s Online Privacy Protection Act, a US regulation, and privacy laws around the world, *TED will not publish content featuring any children under the age of 13**.

*If your child is under 13, signature of this form grants your child permission to participate in the program, with the understanding that his/her Club Leader will be asked to refrain from uploading content featuring your child.

What if I do not want my child’s image to be uploaded to TED? If your child is 13 or over, and you do not wish your child to be included in any content, please let your Club Leader know so that your child will not be recorded. Please remember that this release only covers TED-Ed Club related activities, and that other releases or terms may apply to any other school recordings.

The following terms are required for your child to participate in TED-Ed Clubs. Please read the terms and sign below if you agree.

PERMISSION TO PARTICIPATE

- ✓ You agree that your child can participate in TED-Ed Clubs and receive information and invitations about TED-Ed events, newsletters and other related information by TED.
- ✓ You understand that TED has no liability for any TED-Ed Club activities but has licensed the Club Leader that is employed by the school, organization or institution where the TED-Ed Club is run to be responsible for all in-person and online activities related to TED-Ed Clubs.
- ✓ You release TED from all property damage or personal injury claims arising from your child’s participation in TED-Ed Clubs.
- ✓ This release is governed by the state of New York and contains the entire understanding



between you and TED and may not be modified unless agreed in writing.

- ✓ In the event of a conflict or issue resulting from TED-Ed Clubs, you agree to cooperate in good faith with all parties involved in order to find an amicable resolution.
- ✓ You certify that you are the parent and or legal guardian of the student named on this form and have read this release, and agree to provide permission for student to participate in TED-Ed Clubs and provide Content based on these terms.

- ✓ If you agree with the Club Leader that your child may participate in video recordings, you grant permission for the TED-Ed Club and/or TED to videotape, film, photograph and/or record your child’s activities related to TED-ED Clubs. The Club Leader should inform you of events that are recorded and can coordinate the events so that you are aware when and if they are uploaded to TED. - ✓ You understand that TED owns the content that is submitted to the TED website related to TED-Ed Clubs, including any video, animation, or related content “Content”, unless it is submitted clearly marked under a license or copyright holder. Any personal information, or images or video that is recorded, is only provided with a limited license by you to allow TED to showcase the content on TED-Ed websites and other related events.
